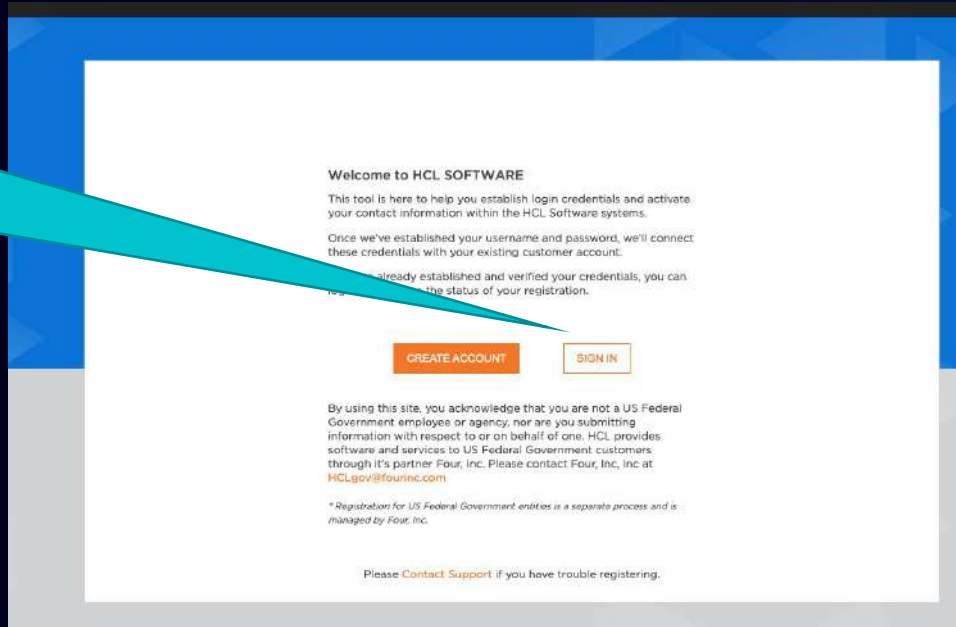

Partner Pack Agreement Highlights

Authorized Use	Description
Demonstration and Evaluation	The Products can be used for demonstrations in the sales and marketing of solutions that feature the Products.
